Governor's Highway Safety Office Launches *Hands Across the Border* Event

Nashville, Tenn. – More than 15,000 passenger vehicle occupants across the United States died in traffic crashes between the nighttime hours of 6:00 p.m. and 5:59 a.m. during 2005, according to the National Highway Traffic Safety Administration (NHTSA) – and 59 percent of those passenger vehicle occupants killed were **NOT** wearing their seat belts at the time of the fatal crash.

The proportion of unbuckled deaths at night is considerably higher than the nearly as alarming 44 percent of passenger vehicle occupants who were not wearing their seats belts and were killed during daytime hours across the nation that same year.

The Governor's Highway Safety Office held several *Hands Across the Border* media events in May. *Hands Across the Border* is designed to bring awareness to this year's national "Click It or Ticket" summer campaign. The media events brought together troopers, local officers, government agencies and traffic safety advocates from Tennessee as well as the South-eastern border states. Agencies in Kentucky, Virginia, North Carolina, Georgia, Alabama, Missouri and Mississippi joined forces with the Volunteer State in a pledge to actively enforce safety belt laws, increase safety patrols and conduct sobriety checkpoints during the heavily traveled summer months. The goal this year is simple: to save more lives by convincing more motorists to buckle up – day and night.

"Clearly more drivers at night, than during the day, are taking the attitude that 'it will never happen to me,' but the risk of a fatal crash actually goes

up significantly at night," Commissioner Gerald Nicely, Tennessee Department of Transportation said. "It only makes sense to protect vehicle occupants by being properly restrained."

Kendell Poole, Director of the Governor's Highway Safety Office said, "Regular seat belt use is the single most effective way to protect people and reduce fatalities in motor vehicle crashes. In 2005, 77 percent of passenger vehicle occupants in a serious crash who were buckled up, survived the crash, and that when worn correctly, seat belts have proven to reduce the risk of fatal injury to front-seat passenger car occupants by 45 percent – and by 60 percent – in pickup trucks, SUVs and mini-vans."

Yet nearly one in five Americans (19 percent nationally) still fail to regularly wear their seat belts when driving or riding in a motor vehicle according to NHTSA's observational seat belt studies.

Stepped-up law enforcement activities were conducted during the national "Click It or Ticket" enforcement

"Seat belts clearly save lives. But unfortunately, too many folks still need a tough reminder, so we are going to be out in force buckling down on those who are not buckled up," said Colonel Mike Walker, Tennessee

Highway Patrol. "Wearing your seat belt costs you nothing, but the cost for not wearing it certainly will. So unless you want to risk a ticket, or worse—your life, please remember to buckle up day **and** night - 'Click It or Ticket.'"
